EWRS MESSAGE

This is the French focal point for EWRS in the Ministry of Health. We have received a message from our consulate in Kiev, Ukraine of the death, overnight, of a French citizen attending the Euro championships in the local hospital in Lviv. The fatality was a boy, age 12. There is no confirmation of the cause at present but the cause of death is likely to be disease but we are waiting for test results from Ukraine. We are aware that two others travelling with the boy, a male 19 and a male 16 both have a rash and fever. We are aware that the media already knows of this fatality and given the concerns aired in the media prior to these championships expect this to become a big issue. Is anyone else aware of deaths or illness in their citizens visiting the Ukraine for the Euros?

EXERCISE BEAIVI

I have heard about the death of the French boy in hospital in Lviv as reported on EWRS this morning. I have talked to the WHO-EURO rep in Kiev. He tells me that there is a lot of pressure on the emergency rooms in the hospitals in the Lviv oblast (region) due to the number of measles patients, many of whom are hospitalised. These are mostly locals and it has been going on for weeks. He also told me that two food handlers have been hospitalised two days ago with paralytic symptoms. As happens in the Ukraine, there is speculation that these cases are associated with a deliberate act of poisoning but he has no further information on these cases or the associated "plot" at this stage. He is attempting to find out more and will ley me know as more information becomes available.

An unnamed Ukrainian doctor working at the Hospital has talked to the press about two patients that were brought into the hospital overnight. They are food handlers, who recently returned from their homes in the Caucases (near Vladikavkas, Russia). The doctor is concerned because they have symptoms consistent with Polio infection and samples have been sent to the Zabalotny National Virology reference laboratory in Kiev for identification. Results are awaited.

EXERCISE BEAIVI

We can confirm that 2 of our field workers in Cairo, Egypt, working in local health clinic, have been diagnosed with suspected H5N1. This is based on symptoms associated with influenza like illness and recent exposure to a person who was later confirmed as carrying the H5N1 virus and has now sadly died. One of the field workers is seriously ill in hospital with severe pneumonia. As I say we cannot at this stage rule out nosocomial infection nor can we confirm that it is the H5N1 virus. However as a precaution they are both being treated with oseltamivir. We expect results from the WHO Global Influenza Surveillance Network laboratory in Cairo in the next 24 hours at which point we will update you.

Rumours Circulating

I have been having a discussion with the WHO-Euro liaison officer in Kiev. He has said the MoH have been trying to come up with strategies to counter rumours currently circulating in the Ukraine. These include rumours of increasing cases of measles, that this is a new strain of measles resistant to available vaccines, and now that there is Polio among fans.

Press speculation in country is saying a new strain of the measles virus is circulating with increased risk of pneumonia, encephalitis and mortality – experts are being rolled out to agree. It is true that EDs are experiencing increased levels of activity with suspected measles cases but that has been true for months and any association with increased number of encephalitis and pneumonia is not confirmed.

However, there are two potential cases of polio in hospital in Lviv. Samples have been sent to Kiev for analysis but this will take time.

Because of all this uncertainty, transport workers in Lviv are threatening to strike because of fears about contracting an infectious disease and are demanding "danger money". UEFA are very concerned as today is the final game in Lviv, between Denmark and Germany, and they don't want any disruption.

Polish Border disruption

Whilst this does not mean the border is closed, it is preventing anybody crossing it other than Polish citizens who are being allowed to cross, resulting in de facto closure. Do we have any more information from the Ukraine that can help resolve this problem? What should we be advising the Polish government?

No formal reason for this delay has been given but I understand that they decided it made more sense to have the press conference after the last game in Lviv was concluded as it would then be clearer where Euro football fans would be expected to move to next and in what numbers.

Ukraine

- Measles vaccinations taking place at the health clinics in fan camp in Lviv.
 Vaccine supplies limited. Expensive.
- Locals complaining about unfair access to vaccine for foreign tourists.
- MoH requesting further supplies of measles vaccine from pharma and neighbouring countries who may have some. Request being made through WHO country office.
- No update on suspected polio cases. No new cases reported.
- Note: Many fans will be entering and leaving Ukraine today and over the next few days as the tournament enters the quarterfinal stage. Portuguese and Germans will be heading for Poland for their next games whilst Italians and Spanish will be arriving in the Ukraine next week as they have both qualified for the quarter-finals. The majority of fans of teams who did not qualify (Denmark, France, Sweden) are expected to start to return home over the next week as the group matches finish.

Detail on press conference and private briefing by MoH in Ukraine (provided by colleague at WHO-EURO attending press conference in Kiev) :-

- Everything under control.
- There is no new strain of measles circulating.
- The death of the French citizen (12yo) in Lviv was probably not due to measles but meningococcal meningitis all close contacts have been traced.
- The measles vaccination that is being offered is being done so by private clinics and is not under the direct control of the ministry.
- Additional supplies of vaccine are being requested by the Ukraine MoH in an attempt to manage the current outbreak more efficiently, not as a result of any other factor. This is separate from the vaccination being done privately at the fan camps which the MoH considers purely a personal additional precautionary decision.
- Ukraine has been offered support by colleagues in WHO and ECDC to provide additional support to the ongoing outbreak investigation.
- The European football championships remain unaffected.
- Ukraine government is in discussions with Poland to relax border control measures and provide reassurance.
- The food handlers in Lviv are negative for polio, one suffers from low blood pressure.

H5N1 Result

The MSF office in Cairo can now confirm that our 2 field workers based here have not, as previously thought, been infected with the H5N1 virus but with a strain identified as H3N2 as confirmed by the WHO Global Influenza Surveillance Network laboratory here in Cairo. Whilst one field worker remains in a serious condition in hospital, we are expecting her to make a full recovery and the other is feeling somewhat better today. Apologies if we caused any alarm but thought it better you should be aware at an early stage.
